

RULES FOR VISITORS TO THE PARK

on the grounds of the Museum of Glass and Jewellery in Jablonec nad Nisou

The park is the property of the Czech Republic and is run by the Museum of Glass and Jewellery in Jablonec nad Nisou.

These Rules for Visitors have been issued in the interests of ensuring undisturbed use of the park and are binding on all visitors.

- 1. Visitors must respect the basic rules of decency, consideration for other visitors and all equipment, and keep the grounds clean and tidy (waste must be placed in the proper containers).
- 2. Visitors may only move around the park along the specified paths. It is prohibited to damage the equipment and facilities in the park, exhibits, or greenery.
- 3. It is prohibited to ride around the grounds in motor vehicles, on bikes, scooters, skates, Segways, skateboards and similar equipment, the entry of motor vehicles to the yard from Lipanská Street is only possible with the permission of the manager. Throwing and kicking the ball or other objects is also prohibited.
- 4. The consumption of alcohol and the use of drugs in the park is prohibited (the exemption being drinks served at museum events).
- 5. Dogs must be kept on a leash in the park. The owner of the dog must clear up after the dog.
- 6. It is strictly prohibited to handle a naked flame in the park, knives or guns, explosives of any kind, flammable or any other dangerous substances or items.
- 7. It is prohibited to disturb other visitors to the park and the residents of adjacent properties with excessive noise. It is prohibited to spend the night in the park or to spend a longer continuous amount of time there.
- 8. Children are only allowed in the park on their own for a short time (to pass through). They may only stay in the park for longer under the supervision of an adult who is responsible for the child.
- 9. Visitors must respect the instructions of museum staff given, in particular, to protect the exhibits on show, **visitor safety**, **the equipment in the park**, and to make sure that these Rules are being respected. Otherwise, staff have the right to eject a visitor from the park.
- 10. The park grounds are monitored by a security camera system. Visitors to the park, and those attending officially-organised events, acknowledge and express their consent to the taking of audio and visual recordings for the needs of the museum and to the reasonable publication of such recordings in the standard way (at the website, in the media, in publicity materials, etc.).
